The course is suitable for those with no firearms experience and includes:

**Duration:** 1-5 Days (depending on experience)

With so many areas of the world experiencing conflict and organised crime, individuals and groups deploying in support of conflict and post conflict scenarios require the correct training to adequately prepare them before entering these hostile environments. Most insurance companies now insist that in such circumstances, preparatory training is undertaken as a matter of course.

The training is given by ex members of the Royal Military Police who have experienced working in hostile environments with the British Foreign Commonwealth Office. The course is thorough and intense with an emphasis on promoting individual and team cohesion. The course is of a mainly practical nature, however all theory lessons are a pre-cursor. The basics of the course include;

- Introduction to Security
- Interpersonal skills
- Communications
- Driving skills
- Personal equipment
- Map reading
- Basic travel procedures
- Security of buildings
- Anti Ambush/Hijack skills
- Mines awareness
- Crisis management
- First Aid
- Working with close protection teams
- Stress and Post Traumatic Stress Disorder
- International Humanitarian law



The HEAT course has been designed to be tailored to specific regional needs or to the exact needs of an organisation or individual. This course is flexible enough to be delivered anywhere in the world where the threat levels allow. The average length of the courses is 3-5 days, with a day course being offered as a refresher.



## Defence and Military Special Forces Training

Longmoor Group has a wealth of experience training a wide variety of defence forces, including Special Forces overseas and international Government agencies. Defence force training ranges from 1 week training packages to instruct topics such as search techniques or defensive driving, to several month-long projects, recruiting, selecting and training teams and individuals for specialist military or defence duties and tasks.

Longmoor Group has the resources to compile training teams to meet the criteria of any form of defence training. As with all Longmoor training, the instructors will be qualified, experienced and experts in their fields, ensuring the highest possible level of training and mentoring.

The defence training capability has previously covered the following topics, which have either been delivered as individual modules or as complete training packages:

- Basic infantry training: covering basic field craft, map reading, battle field first aid, fitness, individual weapons training and basic communications.
- Patrolling and Standard Operating Procedures (SOP's): Advanced navigation, physical endurance training, receipt and delivery of orders, contact drills, patrolling tactics, obstacle crossings and minefield clearance.
- Advanced trauma medicine: tailored to the operating environment of the course, be it urban surveillance or close protection work where the emphasis is on immediate life support, or long range SF roles where the focus is on remote emergency care and evacuation.
- Survival, Evasion, Resistance and Escape (SERE): essential for specialist military units, or personnel operating in hostile territory. The module covers wilderness survival, camouflage techniques and resistance to interrogation methods.
- Mission planning: Particularly important for leadership and management roles for all types of operation; this teaches tactical and strategic planning and follows it through to teach orders structure and delivery.
- Weapons training: Covering specialist and support weapons for individual use and to achieve group effects.



- Dynamic intervention: The complete package as taught to UK SF and Home Office dynamic intervention teams, the 6 week course encompassing mission planning, live firearms, entry techniques and clearance drills.
- Covert Rural Operations Procedures (CROPS): Teaching specialist surveillance and observation, this module covers observation posts, photography, covert electronic communications and counter surveillance measures.

The highest cause of injury to personnel and damage to equipment remains the road traffic accident. High Networth Individuals and VVIPs are most susceptible to the threat of kidnap or petty crime whilst they are driving.

They keep order and make sure that people are safe. One of their main duties is to check the suitability of people coming into the venue. It is now illegal to work as a door supervisor in England and Wales without an SIA licence. Door supervisors in Scotland will need a licence from November 2007.
